14. Old Business

- a. Vote on MCANA Proposed Budget 2025
 - i. Voted passed 15 yes, 5 against, 0 abstentions
- b. Vote on the 2025 Guidelines
 - i. Vote did not pass
 - ii. The group asked for the Guidelines Ad-hoc Committee to plan another meeting to revise the guidelines. Some corrections or additions need were, guidelines did not list the Women's Brunch Committee, correct the entity name of Monterey-San Benito County of Area of Narcotics Anonymous and other corrections.
- c. Storage Facility
 - i. Diego stated that after reviewing the budgets we don't have to funds to get another storage and suggested two options.
 - A) get a group together to organize our current storage or
 - B) the committees can donate a portion of their budgets towards another storage
 - 1. Ken stated that the storage facility was originally intended and purchased for ASC/H&I/PI literature and all the equipment needed to make it work and the printer/ink/paper. So asking for more money when it was already intended for that purpose seems unfair. What our committee members need is room to fill those orders once a month. Right now there is no shelf space so organizing it would be great.

- 2. Christina & Peter volunteered to organize the storage facility and put together a sign-up sheet for anyone else willing to join.
- 3. Diego quoted the prices for units at Marina Storage:

8x13 is \$225 a month

10x10 is \$250 a month

10x13 is \$300 a month

10x16 is \$350 a month

10x30 is \$490 a month

4. Ken asked what size we are renting now. Diego said an 8x10 that cost \$117 which we are grandfathered in at that price.

- a. Hollister Home Group
 - i. Jeff stated that we (HHG) been asking for some time if we can get attached to MCANA bank account and if that's been figured out yet.
 - 1. Summer said she doesn't have access to our bank accounts right now and needs to get the statement of information brought up to date because it was due in April of last year and haven't gotten on there. She's registered and is waiting for pin in the mail and expect it in the next 7 to 10 days. As soon as she gets that she'll update the statement of information. She asked if it has already been approved in the past to add a bank account.
 - 2. Jeff said no they are still trying to figure that out
 - 3. Summer said to bring that at that point once she has access and she's updated the statement of information.
 - 4. Anne stated that she doesn't understand the request.
 - 5. Summer said they want their own bank account to hold their money.
 - 6. Summer added that her goal is to get our account set up correctly (as a business account), because it's not currently set up as a business account which means each individual account cannot have their own Zelle which is an issue. She suggested to put a motion to open a new bank account under Monterey County Area so Hollister Home Group can manage and hold their funds in their own account under this body's bank account.
 - ii. Peter has merchandise from a Spiritual Retreat he acquired and sold them to members of the group.
