We really rely on the fellow. I mean on the treatment center from King City that goes over on Tuesdays and they don't go over all the time. So we do have a meeting, but we don't have a gsr. We do have a treasurer and we have a secretary."

- 6. Diego "Yes, yes, yes. So like I was going to. I was supposed to step up to gsr. Then I found out I can't be a GSR because I'm a chair.And then our treasurer there, he's been treasured.He has like 17 years clean, like, so we got some pretty good recovery there.It's just there's so little of us. If the treatment center. Yeah, if the treatment center doesn't go, there's going to be four county meetings.Have always struggled in this area just because."

- 8. Diego "There are. There's tons. There's a lot."
- 9. Melissa "What meeting are you talking about?"
- 10. Diego "It's Tuesday night, solar death. It's at 7 o' clock to 8. It's a cool little me. I mean, it's my home group. I make it every week. There's. There's a little group of us that go every week. And it is what it is, but we keep the doors open, we pay the rent."

15. Motions

- i. Kevin "Name is Kevin. I'm an addict. As previously stated. Today's date. State the motion. Pay storage says rent for June at \$177 including late charge and six months at new rate of 230 beginning July and the amount would be \$1557. So trying to pay six months for that. Submitted by Ann there. Change the guidelines. No, no, no"
 - 1. Mike "what was that total again?"
 - 2. Kevin "\$1500, July through December, I would say."
 - 3. Diego "Open it up for discussion"
 - 4. Phil "My name is Phil, as I understand that we were paying \$177 a month, and now they want to raise it up to how much? 230. So we're \$65 more a month. Just as suggestion made me fish around and find another place and did.
 - 5. Diego "I was about to say. So I was about to say we did do the. The fishing round. It looked like it was. They were grand. I know it looked like they were giving us that price, but now they're switching it.So I like that price of one of 165. That was a great, great price when we were looking around. Unless you have, which it sounds like you might have some hookups. You know, we love the hookups. I'm just saying. Oh, maybe a little bit of fishing around. Right. So we did do the fishing around a couple months ago. Yeah. We did this whole thing, and it looked like the best deal that we were getting was from where we were asked. Yeah. But what sucks is that they're. They're not letting us have that grandfather's price anymore. They're going to raise it up. Yeah, yeah. That's quite a

- bit. But an did a little bit of fishing on her own already, and she. It looks like Marina storage has the best price for us anyways. 285. Yeah. Yeah, 285. 10 by 10. Is stock full, right?
- 6. Theodore "Yeah, it is. I got a question. What's up? Is that fifteen hundred dollars for a month?
- 7. Diego "No, for six months. Six months. Six months. Six months. Plus this month. Plus seven months. Well, gives us six months to find another place if we want to get there. Anyone else have anything they want to add to this, So it looks like we're ready to vote. I'm gonna ask I'm gonna say the votes, and then you count them out. All right, so a motion to pay that. Oh, yeah. Is there anyone who abstains from this? Any oppose, now you have to call. Okay, so let's do the vote then. All in favor of paying six months, why not just cap the room?"
- 8. Erin "And if you're visiting and you're not a GSR and you're representing a meeting, you do not have a vote. Thank you. So that meeting is technically absent. If you are. If you are here on behalf of a meeting and you are not the present GSR or code gsr, you do not have a vote. So I see people with hands up that came in and said they were visiting and representing AGSR. They should not be voted."
- 9. Diego "So to clarify what everyone's saying, if you guys are stepping up and just sitting in for the gsr, you do not have a vote, It looks like we just went anyway. All right, so 23, 4. One opposed, one and one abstention. So it passes.
- ii. Kevin "Today's date. State the motion. Pay rent for every service meeting to this place, the veterans transition center, for June. The amount is \$60. Okay. All right. All right. Yeah. Yeah. All right."

16. New Business

- a. Mike "Yes. Hold on one second. So our guidelines state that was supposed to have \$7,000 in our account. I just want to bring it to this body. We have. I heard that \$20,000. If I heard that RCM report right, they had to pull some remote money out of their operating reserve to take cover, some checks and things like that. Right now we have the 17,221 six nine, minus the 680811, minus the 1557. Minus the 60. Yeah, equals. Oh, wait. Equals. We're 1800 60, 56.58 over what we're supposed to have in our account. So I cannot make a motion because I'm a visitor. Thank you for recognizing me, but I can make a motion, too."
- b. Nick "Can I get a question? Yeah. Will that 1500 we pay for storage come out of that?"
- c. Anne "And we have not received the bill from the lawyer yet.Oh, and the tax fees."
- d. Mike "Should you know we should have that by next month"
- e. Anne "We should have it by now. But I'll be on it tomorrow. I'll be calling her. She said she was going to send me all the copies.
- f. Diego "So lets table this till next month"

17. Open Forum

a. Mark "And the Hollister Home Group wants a report from NBC and me for the last two cycles. I don't know who we're going to talk to about that. Maybe she could take it back

- to Tish and ask for that. They want the financials, they want the, the attendance. The commission has come for the last two cycles and we would like a RCM report, Like. Like, like it. You would like it like the financial report? Put in the RCM report also, if that's possible."
- 1.Erin "are you asking for them? So are you asking to put the two years of the financial report in their report and submit it to Region?No. No. So what are you. I'm confused by what you're asking?
- 2.Mark "Wants a full report of the last two conventions.
- 3. Mike "So. Okay, Mike, I just would like to put into the RCM report that there's a member, there's a group of our area that is asking about. Asking for NBCNA financials for the last two cycles and we haven't received anything. But they're still in the process. I know you can't answer the question. My thing is they're still in the process from two years ago."
- 4. Diego "Two years ago, no that makes sense."
- 5. Nick "Yes. Am I mistaken? Wasn't like two months ago the debate on whether or not they were responsible for providing that to us?Yes. Did we ever land anywhere on that or is that still up there?
- 6. Mike "Yeah, they're still. Until something's taken out of the guidelines, they're still responsible."
- 7. Nick "Okay, but they're, they're positioned position or their point of view is that they don't technically owe it to us."
- 8. Mike "Yes, they do. Our guidelines and their guidelines say that they're to report to this committee and to let us know what's going on."
- 9. Nick "I'm agreeing with you. Does their committee share that? I don't know. And if they don't want to report to us, it should be Very simple.We gave them like five grand. I want to say probably three or four years ago when they were short for seed money, they could give us our money back and then they, you know, if this body decided it wouldn't have to report to us anymore.But we, we don't have. We. We haven't gotten a report for two cycles."
- 10. Kevin "Yeah, my name is Kevin. I'm an addict. Didn't she give up some kind of monies last month or something?"
- 11. Mike "No, she didn't. So a report. What she gave was. She gave our treasurer their bank statement or whatever's in the bank statement. That, that is the fellowship should know. Hey, we sold \$25,000 worth of merchandise. There was 4,500 people that enjoyed the convention. We had 33,700 Saturday only registration. We had a total of 15,000 registered for the OR. I got you. I just, you know, everything. We haven't seen their. We don't even know what their budget is. Like nccna, everybody. We can get a copy of their what their budget. Hey, this is what we have budgeted for this. This is what we have budgeted. At the end they'll give, they'll give us a report that will be given to the, to our rcm. Put on the drive, said, this is what we made. This is how many registrations we sold. This is how many T shirts. And we haven't seen any of them."

- 12. John Paul "Yeah. JP so is that different from the report that was submitted this month and last month?"
- 13. Tim "Has anybody from this body gone to that meeting and, and specifically talked to them about that?"
- 14. Diego "our previous chair, I believe did that."
- 15. Kristel "So you guys should send a physical person to that meeting.Not, not, not online. Online. And somebody that's going to speak up at their next meeting."
- 16. "Their next meeting Their next meeting is June 12th at 6:30, in moss landing"
- 17. Diego "So then to reclarify what you also want was asking, what your group was asking was that our rcms report to the art to the region that we've been trying to get the statements for the past two events correct."
- 18. Mike "I. I just. The RCM report should. Should say like what in there? Like our open. It should have our financial. Should have all of that stuff. Right. One of our open topics questions was we were asking for a report, financial report. Because we haven't received one for the last two years. They might last two cycles. That's four years. The region knows. Some of the other RCMs might say, hey, this is how we've dealt with this in a convention in our area. This is how, you know, so we can get some feedback from our rcms, them to bring back to us here."
- 19. Diego "Okay, perfect. Yeah. RCM 1 and 2. Did you guys hear that?"
- 20. Nick "Reguest is coming from the hollister home group, Would it be more impactful or is that something like that the area committee would request? Like area wants it, not just the home. I would go better to take a straw poll of our area as well and get a full on."
- 21. Rosie "That's a good idea. So that's what we're going to do then. Yeah, I know what's. I know they're going to ask was that a meeting or is this how's your area?You know, these are valid questions that they're going to ask."
- 22. Diego "So let the record show that Hollister is bringing it up and now we're taking a straw pull as an area body. So here we go. We're going to go. All in favor for us going for asking for the report for the last two cycles of our RCM from our area. Of our RCM to Mon to the nbcna. Okay. All in favor, raise your hand. I'm so used to doing it. Count it up. Count it. Oh, sorry. Count it. 1, 2, 3, 4, 5, 6, 17, 18, 19, 20, 21, 22, 22. Okay. All against."
- 23. Mike "Theodore, are you going to be able to carry this body's request to the region? Well, if we voted yes, he bo. He said no. So he's our rca. I want to make sure he's going to bring our. This body's voice. Yeah, not his. Okay, well, I'll tell you what."
- 24. Theodore "Yeah, not his. Okay, well, I'll tell you what. They. They haven't finished closing out 46 yet and I was not the RCM for 45."
- 25. Kristina "before you speak, can you please announce yourself?
- 26. Diego "Theodore is on board. And. And if you need a backup, Rosie's there. Okay. Any other open forums?"

- 27. Jim "I'm an addict. I am the coordinator for the fire camps in Solidad and I've been going in by myself because I had no clearance forms. I got a clearance form. I'm going to make copies. I will bring some here at next area. I'm going to leave some at H and I and spread some around. All right. It's a lot easier to get into fire camp than it is the prisons."
- 28. Mike "What is the fire camp and when do they meet?"
- 29. Jim "it's not at the prison. It's just before the gate there. You make a right before they. And this is Gab. And on Fridays at 6 o'. Clock."
- 30. Erin "My name is Aaron. Also, if anybody care to join me Thursday night at the NBCNA subcommittee meeting, feel free to.To come alongside. This Thursday."
- b. Alyssa "i am a visitor and very late today, I apologize for that. So basically there is a meeting that we started. Well, sun street has every Thursday night at 7:30.I know that they previously had somebody come to area. When I used to come to area, they would announce. It's called Keeping it simple, meaning we're looking for support. I know that it is an hour drive from Salinas and it sucks to drive that far, but I drove very far from my dope, so. That's right. So we would appreciate some support out there. It's at 7:30. There's a lot of men and women in that facility that are hungry for recovery and it would be nice to have some support out there."
